Why Attend Advocacy Day?

The Cultural Advocacy Network of Michigan represents statewide cultural organizations by advocating on their behalf in the Michigan Legislature. By participating in Advocacy Day, you will help establish a presence for cultural organizations in state government and be able to develop strong relationships with your local legislative leaders. Attendees will gain insight into the processes related to policy-making and appropriations from individuals involved with such work on a day-to-day basis. Additionally, Advocacy Day provides a venue for you to network with members of other statewide cultural organizations, creating opportunities for collaboration in the future.

Currently, the Cultural Advocacy Network of Michigan is working on several issues that directly affect cultural organizations. Three of these issues will be our focus during the upcoming Legislative Day:

- Introduction of the Cultural Advocacy Network
- Funding for the Michigan Council for Arts and Cultural Affairs
- SB 54 Reinstatement of Historic Preservation Tax Credit

It is important that we build relationships with our legislators in order to have our interests effectively represented. What is the best way to do that? By having constituents visit them and explain why these issues are important. An appointment will be scheduled for you with each of your legislators. Our lobbyist, Melissa McKinley of Kelley Cawthorne, provides an update and briefing to familiarize you with the legislative issues to be discussed. A packet of information on legislative topics and the CAN-MI members is provided for each legislator. You will also have a chance to meet with the legislators and staff members at the luncheon.
